The goal of the AHHA Performance Award, is to encourage and recognise Heavy Horses and their owner / riders.

Once a horse accrues 500 POINTS, you must send your Performance Awards into the AHHA Secretary for them to be verified. Your horse will then be awarded a beautiful headstall with the horse's name engraved on it.

Once a horse accrues 1000 POINTS it will be awarded with a cotton rug featuring their name and the AHHA Performance Award logo.

1. Performance Award points are attributed to each registered horse

- 3. There is no time limit on the accumulation of Performance Award points
- 4. Members are responsible for the completion of all Performance records
- 5. Performance Award files will be maintained by the Performance Award Manager and published regularly on our website.
